#### OLD BUSINESS

(At Trustee Muhammad's request, Mayor Rogers deferred Item A until after Items B and C.)

B. Ordinance No. 17-022
Amending Section 4-4-2(K) Relating to Hours when Basketball may be Played in Certain Zoning Districts

Trustee Pierson said that he has heard residents' objections to the ordinance he had proposed and that had been passed by the board limiting prohibiting residential playing after 6 p.m. This ordinance restores the provision prohibiting playing after 8 p.m. There being no discussion:

#### A. Ordinance No. 17-021

Amending Ordinance No. 17-018 Adopting an Appropriation and Budget Ordinance for the 2017-2018 Fiscal Year

Trustee Muhammad read his statement supporting the ordinance, a copy of which is attached to these minutes.

Finance Director Yvonne Redmond outlined the amendments:

Salary reductions for select administrative employees are restored. The deputy fire chief position is restored. Previous line items for additional positions in the fire and finance departments, and the village administrator are deleted. The village is implementing furlough days for non-union employees.

Trustee House asked that the ordinance be tabled until the next regular meeting to allow time to consider.

Mayor Rogers questioned whether the village could operate without a village administrator. Trustee Muhammad commended Ms. Johnson and Ms. Redmond for managing day to day operations and said that the board will consider the need for an administrator in the future. In response to Mayor Rogers' question, Trustee Muhammad responded that the board is extending Stan Urban's consultant agreement to "tie-up loose ends" regarding collective bargaining and sale of the Dorchester. Mayor Rogers said that the village needs an administrator.

Trustee Henyard said that she will not vote for what she sees is a 5% increase.

Trustee House said that he will be voting no on the ordinance today only because he requires more time to review the proposed budget.

#### A. Ordinance No. 17-023

Amending Title 3, Chapter 2 of the Dolton Village Code to Provide for a Package Liquor Tax

# C. Ordinance No. 17-025

Amending Section 7-6-7-1 of the Dolton Village Code, "Water Rates Established".

Brian Marciniak, payment center manager, addressed questions by the trustees. Apartment buildings of four units or more are to be charged at the same rate as commercial properties.

# D. Ordinance No. 17-026 Declaring a Village-Wide Hiring Freeze

# CITIZENS ADDRESS

Cathy Bendell, former trustee and resident, questioned the minimum water billing of 10 units, as many, especially seniors, do not use that much, and questioned why the new ordinance imposed only \$5 sewer charge per residential building when homeowners are to be charged \$5.

Pat Harris, resident, questioned salary levels at \$55-65,000 per year when residents don't see what the employees are doing. Resident said that the village needs more police and fire personnel.

Patrick Walsh, attorney, questioned the reduction of certain employees' salaries. He also asked about an online notice purportedly by the village to recruit a part-time director of Public Works.

Village Attorney Murphey confirmed that per state law, there cannot be any reduction in compensation of current elected village officials. Trustees Muhammad and Stubbs pledged to donate back 5% of their annual salaries.

Felita Crayton, resident, asked about the sale of the Dorchester.

Arthur Adams, 30-year resident and public works employee, said that there are public works employees who have the skill sets to take care of sewer problems.

In response, Mayor Rogers noted past problems in calling out public works employees for emergencies.
